MEMORANDUM CIRCULAR
NUMBER 2022 - 064

SUBJECT: SUPPLEMENTAL TO MEMORANDUM CIRCULAR NO. 2022-060 RE: REOPENING OF APPLICATION FOR THE ISSUANCE OF NEW CERTIFICATES OF PUBLIC CONVENIENCE (CPC) UNDER THE IMPLEMENTATION OF PUBLIC UTILITY VEHICLE MODERNIZATION PROGRAM (PUVMP) FOR NCR ROUTES

WHEREAS, on 19 June 2017, the Department of Transportation (DOTr) issued Department Order No. 2017 – 011 also known as the Omnibus Guidelines on the Planning and Identification of the Public Road Transportation Services and Franchise Issuance adopting the rules and procedures for the issuance of the franchises for public transport routes and services;

WHEREAS, pursuant to Section 5(a) of Executive Order No. 202, dated 19 June 1987, the Land Transportation Franchising and Regulatory Board (LTFRB) shall have the power to “prescribe and regulate routes of service, economically viable capacities and zones or areas of operation of public land transportation services provided by motorized vehicles, xxx”;

WHEREAS, on 20 June 2022, the Board issued Memorandum Circular No. 2022-060 known as the “Reopening of Application for the Issuance of New Certificates of Public Convenience (CPC) under the Implementation of PUVMP for NCR Routes”, which resolved to proceed with all the pending processes involving the Selection Process for NCR routes with no takers;

WHEREAS, in order to properly proceed with the implementation of said circular and for interested applicants to be clarified on the schedule of the Selection Process, the issuance of this supplemental guideline is deemed necessary;

NOW THEREFORE, for and in consideration of the foregoing, Memorandum Circular No. 2022-060 is hereby supplemented to include the schedule for the Selection Process per NCR route as follows:

The pre-qualification conferences shall be held on the indicated date below:

Letter of Intent and qualification documents shall be submitted **NOT LATER THAN** the indicated deadline below:

Opening of the sealed documents will immediately follow on the indicated date below:

This Memorandum Circular amends and supersedes all issuances inconsistent herewith, and shall take effect immediately following its publication in a newspaper of general circulation and the filing of three (3) copies hereof with the U.P. Law Center pursuant to Presidential Memorandum Circular No. 11 dated 09 October 1992.
