COMMITTEE RESOLUTION NO. 135Series of 2022

(Re: Selection Process for the route: Laguindingan, Misamis Oriental to Marawi, Lanao Del Sur under MC No. 2021-071)

WHEREAS, relative to the opening of Applications for the Issuance of New CPC for the route: Laguindingan, Misamis Oriental to Marawi, Lanao Del Sur under MC No. 2021-071, two (2) applicants submitted their qualification documents to the Office of the Executive Director on 23 December 2021, namely: New Mindanao Transport Service Cooperative (NEMINTSCO) and JK-Line Transport Inc.;

WHEREAS, in the selection proceedings conducted on 16 February 2022, both applicants New Mindanao Transport Service Cooperative (NEMINTSCO) and JK-Line Transport Inc. were rated as "**PASSED**" for each criterion on the required Qualification Documents as set forth under Memorandum Circular No. 2019-013 Item V-A-3e ;

WHEREAS, on 20 April 2022, Resolution No. 078, series of 2022 was issued, approving the recommendation of the Qualification Committee to allow herein applicants to decide whether to equally distribute the authorized number of units among them or proceed with the public lottery as provided under the rules;

WHEREAS, pending receipt of the decision of the applicants, this Committee received a letter from the Office of the City Mayor of Marawi City, signed by the City Mayor Atty. Majul U. Gandamra stressing that the Letter of Support submitted by applicant NEMINTSCOA in its qualification documents is fictitious as it was not duly issued by his office or from the office of the Vice Mayor who are authorized to issue document relating to the use of Marawi Integrated Food and Transport Terminal, thus, requesting to invalidate the same;

WHEREAS, it is the impression of the Committee that the letter of Mayor Gandamra may have an impact on the current status of the application of NEMINTSCO considering that the assailed document is one of the qualification documents being considered during the evaluation;

NOW THEREFORE, for and in consideration of the foregoing, this Committee hereby **DIRECTS** applicant NEMINSTCO to explain in writing and to submit within five (5) days from receipt hereof, as to why it should not be disqualified in the ongoing selection process. Failure to submit an explanation within the given period shall be deemed a waiver on its part to be heard, and this Committee shall immediately resolve the complaint based on the available records.
