

**RESOLUTION NO. 101 Series of 2019**  
**(Re: PRE QUALIFICATION OF**  
**PREMIUM POINT TO POINT SERVICE)**

**WHEREAS**, the Land Transportation Franchising and Regulatory Board (LTFRB) issued a Memorandum Circular No. 2019-010 (Re: Implementing Guidelines on the Opening of Proposed Additional Premium Point to Point Bus Service) dated March 5, 2019.

**WHEREAS**, the Board has created a Pre Qualification Committee for the Accreditation of Premium Point to Point Bus Service;

**WHEREAS**, on 1 April 2019, the Pre Qualification Committee opened the sealed envelopes/boxes submitted by the applicants for additional PREMIUM POINT-TO-POINT SERVICES IN **PACKAGE 12** for the route : **(a) PHILIPPINE ARENA-CLARK; (b) PHILIPPINE ARENA-CALUMPIT, BULACAN; (c) PHILIPPINE ARENA-LA UNION; (d) PHILIPPINE ARENA- CENTRAL (QC)** with the total units of eighty six (86), **PARTAS TRANSPORTATION CO. INC.**, submitted the qualification documents.

**WHEREAS**, Applicant **PARTAS TRANSPORTATION CO. INC.** was given by the Committee a "FAILED" rating for applying only ONE route for the package.

**NOW THEREFORE**, the Pre Qualification Committee resolves to recommend to the Board to **RE-OPEN** to prospective applicants **PACKAGE 12 (a) PHILIPPINE ARENA-CLARK; (b) PHILIPPINE ARENA-CALUMPIT, BULACAN; (c) PHILIPPINE ARENA-LA UNION; (d) PHILIPPINE ARENA- CENTRAL (QC)** of the PREMIUM POINT TO POINT SERVICE under MC 2019-010.
