

**RESOLUTION NO. 103 Series of 2019**  
**(Re: PRE QUALIFICATION OF**  
**PREMIUM POINT TO POINT SERVICE)**

**WHEREAS**, the Land Transportation Franchising and Regulatory Board (LTFRB) issued a Memorandum Circular No. 2019-010 (Re: Implementing Guidelines on the Opening of Proposed Additional Premium Point to Point Bus Service) dated March 5, 2019.

**WHEREAS**, the Board has created a Pre Qualification Committee for the Accreditation of Premium Point to Point Bus Service;

**WHEREAS**, on 1 April 2019, the Pre Qualification Committee opened the sealed envelopes/boxes submitted by the applicants for additional PREMIUM POINT-TO-POINT SERVICES IN **PACKAGE 5** for the route : **CLARK - BAGUIO** with the total units of thirty (30), the following prospective applicants for Premium Point to Point Service submitted their respective Qualification Documents:

- 1) Luzon Cisco Transport Inc.; and
- 2) Victory Liner Inc.

**WHEREAS**, Applicant **LUZON CISCO TRANSPORT INC.**, was given by the Committee a "FAILED" rating for failing to comply with the Technical Qualification requirement by submitting an unsigned Undertaking for Delivery Schedule and for failure to submit the Board Resolution authorizing the signatory to lease the units;

**WHEREAS**, Applicant **VICTORY LINER INC.** was given by the Committee a "FAILED" rating for failing to comply with the Technical Qualification requirement as the documents as a proof of terminal failed to comply with the minimum requirements as provided by the existing Memorandum Circular particularly the terminal's end point is on-street and the Contract of Lease for interim units is not the original copy.

**NOW THEREFORE**, the Pre Qualification Committee resolves to recommend to the Board to **RE-OPEN** to prospective applicants **PACKAGE 5 (CLARK-BAGUIO)** of the PREMIUM POINT TO POINT SERVICE under MC 2019-010.
