RESOLUTION NO. 087 SERIES OF 2019

(RE: OPENING OF APPLICATIONS FOR THE ISSUANCE OF NEW CPCs TO OPERATE ADDITIONAL UV EXPRESS SERVICE IN CERTAIN ROUTES IN CAVITE TERMINATING AT PITX - SELECTION OF GUARDIANS POLICE BANTAY PAMILYA TRANSPORT COOPERATIVE)

WHEREAS, on 26 February 2019 applicant Guardians Police Bantay Pamilya Transport Cooperative was issued with a Notice of Conditional Selection regarding its application for the routes Brgy. Paliparan, Dasmariñas, Cavite to PITX via Molino and Molino, Bacoor, Cavite to PITX to operate UV Express pursuant to Memorandum Circular No. 2018-027.

WHEREAS, in the application, applicant proposed twenty-one (21) units for each of the applied above-mentioned routes.

WHEREAS, in the issued Notice of Conditional Selection, the Pre-Qualification Committee has given the applicant ninety (90) days from receipt of their Notice to submit the documentary requirements hereunder stated and in case of its failure to comply within the specified period will automatically nullify and render void ab initio the issued Notice and its selection as the operator of the applied route;

1. Garage and Terminal location prescribed under the OFG on the Paliparan endpoint;
2. Documents to prove that the cooperative as available financial resources equivalent to or exceeding the amount of two million (P2,000,000.00) multiplied by the total number of vehicles applied for;
3. Cooperative Annual Performance Report duly issued or received by the CDA;
4. Certificate of Good Standing duly issued by the OTC;

WHEREAS, the applicant submitted its compliance on 27 March 2019 and was evaluated by the Committee on 26 April 2019;

WHEREAS, the committee found no Certification or Letter of Support from PITX allowing the cooperative to use the same as its terminal;

NOW THEREFORE, this Pre-Qualification Committee resolves to recommend the Board to **NULLIFY AND RENDER VOID AB INITIO** the issued Notice of Conditional Selection dated 26 February 2019 issued to Guardians Police Bantay Pamilya Transport Cooperative for the routes Brgy. Paliparan, Dasmariñas, Cavite to PITX via Molino and Molino, Bacoor, Cavite to PITX to operate UV Express for failure to comply with the

documentary requirements set forth under the said Notice and the Memorandum Circular No. 2018-027, including the Certification or Letter of Support to use PITX. This is however without prejudice on its part to re-apply or submit application in case the subject route is subsequently re-opened.
