

**RESOLUTION NO. 093 Series of 2019**  
**(Re: PRE QUALIFICATION OF**  
**PREMIUM POINT TO POINT SERVICE)**

**WHEREAS**, the Land Transportation Franchising and Regulatory Board (LTFRB) issued a Memorandum Circular No. 2019-010 (Re: Implementing Guidelines on the Opening of Proposed Additional Premium Point to Point Bus Service) dated March 5, 2019.

**WHEREAS**, the Board has created a Pre Qualification Committee for the Accreditation of Premium Point to Point Bus Service;

**WHEREAS**, on the scheduled date provided under above Memorandum Circular on the opening of additional PREMIUM POINT-TO-POINT SERVICES IN **PACKAGE 1** for the route : **(a) ANGAT, BULACAN - NORTH EDSA (QC); (b) ANGAT BULACAN-LAWTON** with the total units of thirty eight (38), the following prospective applicants for Premium Point to Point Service submitted their respective Qualification Documents:

- 1) Aguila bus Transport Corp.
- 2) First North Luzon Transit Inc.
- 3) Luzon Cisco Transport Inc.
- 4) Pangasinan Five Star Bus Co. Inc
- 5) Baliwag Transit Inc.

**WHEREAS**, Applicant **AGUILA BUS TRANSPORT CORP.** was given by the Committee a "FAILED" rating for failing to comply with the Technical Qualification requirement by not submitting the Undertaking that the units shall be compliant with the specifications and standards under OFG and DTI-PNS; and as the Tax Declaration submitted will show that the same was issued in favor of Zandil Corporation.

**WHEREAS**, Applicant **FIRST NORTH LUZON TRANSIT INC.** was given by the Committee a "FAILED" rating for failing to comply with the Technical Qualification requirement as the Contract of Lease submitted will show that the Lessor and Lessee are one and the same person in the name of Rolando De Leon. However, no Board Resolution from both companies were submitted to show authority of Mr. De Leon to execute such Contract of Lease.

**WHEREAS**, Applicant **LUZON CIZCO TRANSPORT INC.** was given by the Committee a "FAILED" rating for failing to comply with the Technical Qualification requirement as the document submitted as proof of garage a mere Affidavit issued by the President of Marc Realty in the person of Mr. Cesar Hernandez but no Board Resolution from Marc Realty was attached authorizing Mr. Hernandez to issue such Affidavit in favor of applicant Luzon Cisco.

**WHEREAS**, Applicant **PANGASINAN FIVE STAR BUS CO INC.** was given by the Committee a 'FAILED' rating for failing to comply with the Financial Qualification requirement as the Credit Line Certification issued by Metrobank will shows that credit line shall be available on an uncommitted basis at the sole discretion of the issuing bank and shall be cancellable at any time without need for notification to any party.

**WHEREAS**, Applicant **BALIWAG TRANSIT INC.** was given by the Committee a "FAILED" rating for failure to submit the following documents: a) Plan for Interim Service; b) Proof of terminal; c) Or/Cr's for ready units; d) Certificate of Incorporation; and e) Evidence of formal arrangement with Automatic Fare Collection (AFC) and for failure to comply with the above memorandum by applying for only one route to this package.

**NOW THEREFORE**, the Pre Qualification Committee resolves to recommend to the Board to **RE-OPEN** to prospective applicants **PACKAGE 1 (a) ANGAT, BULACAN - NORTH EDSA (QC); (b) ANGAT BULACAN-LAWTON** of the PREMIUM POINT TO POINT SERVICE under MC 2019-010.
