

**RESOLUTION NO. 094 Series of 2019**  
**(Re: PRE QUALIFICATION OF**  
**PREMIUM POINT TO POINT SERVICE)**

**WHEREAS**, the Land Transportation Franchising and Regulatory Board (LTFRB) issued a Memorandum Circular No. 2019-010 (Re: Implementing Guidelines on the Opening of Proposed Additional Premium Point to Point Bus Service) dated March 5, 2019.

**WHEREAS**, the Board has created a Pre Qualification Committee for the Accreditation of Premium Point to Point Bus Service;

**WHEREAS**, on 27 March 2019, the Pre Qualification Committee opened the sealed envelopes/boxes submitted by the applicants for additional PREMIUM POINT-TO-POINT SERVICES IN **PACKAGE 2** for the route : **(a) BALAGTAS, BULACAN - NORTH EDSA; (b) PANDI, BULACAN-NORTH EDSA (QC); (c) PLARIDEL, BULACAN- NORTH EDSA** with the total units of forty five (45), the following prospective applicants for Premium Point to Point Service submitted their respective Qualification Documents:

- 1) Precious Grace Transport
- 2) HM Transport
- 3) Bovjen Transport Service Inc.
- 4) First North Luzon Transport Inc.
- 5) Luzon Cisco Transport Inc.
- 6) Pangasinan Five Star Bus Co. Inc
- 7) Goldenbee Transport

**WHEREAS**, Applicant **PRECIOUS GRACE TRANSPORT**. was given by the Committee a "FAILED" rating for failing to comply with the Technical Qualification requirement by not submitting the Board Resolution authorizing Melisa Lim to lease the busses of Commuters Bus Corp and as the Contract of Lease for interim units submitted will show that the lessor is the applicant Grace Joaquin instead of the registered owner Melissa Lim.

**WHEREAS**, Applicant **HM TRANSPORT INC.** was given by the Committee a rating of "QUALIFIED" as submitted complete Qualification Documents and was given a rating of "PASSED" for each criterion

**WHEREAS**, Applicant **BOVJEN TRANSPORT SERVICE INC.** was given by the Committee a "FAILED" rating for failing to comply with the Technical Qualification requirement by not submitting the Board Resolution authorizing Allan Pua to sign Contract of Lease for the units and as Certification issued by Cross Country will shows that the same undertake to deliver only twenty (20) units;

**WHEREAS**, Applicant **FIRST NORTH LUZON TRANSPORT INC.** was given by the Committee a "FAILED" rating for failing to comply with the Financial Qualification requirement as the Credit Line Certification issued by Metrobank will shows that credit line shall be available on an uncommitted basis at the sole discretion of the issuing bank and shall be cancellable at any time without need for notification to any party.

**WHEREAS**, Applicant **LUZON CISCO TRANSPORT INC.** was given by the Committee a "FAILED" rating for failure to comply with qualification documents for failure to submit Board Resolution authorizing Cesar Hernandez to sign the contract of lease for interim units on behalf of lessor Pangasinan Five Star.

**WHEREAS**, Applicant **PANGASINAN FIVE STAR BUS CO INC.** was given by the Committee a 'FAILED' rating for failing to comply with the Financial Qualification requirement as the Credit Line Certification issued by Metrobank will shows that credit line shall be available on an uncommitted basis at the sole discretion of the issuing bank and shall be cancellable at any time without need for notification to any party.

**WHEREAS**, Applicant **GOLDENBEE TRANSPORT** was given by the Committee a "FAILED" rating for failure to comply with the above memorandum by applying for only one route to this package.

**NOW THEREFORE**, the Pre Qualification Committee resolves to recommend to the Board to **AWARD** in favor of **HM TRANSPORT INC.**, to process further its Application for **PACKAGE 2 (a) BALAGTAS, BULACAN - NORTH EDSA; (b) PANDI, BULACAN-NORTH EDSA (QC); (c) PLARIDEL, BULACAN- NORTH EDSA** of the PREMIUM POINT TO POINT SERVICE under Memorandum Circular No. 2019-010;
