

RESOLUTION NO. 095 _ Series of 2019
(Re: PRE QUALIFICATION OF
PREMIUM POINT TO POINT SERVICE)

WHEREAS, the Land Transportation Franchising and Regulatory Board (LTFRB) issued a Memorandum Circular No. 2019-010 (Re: Implementing Guidelines on the Opening of Proposed Additional Premium Point to Point Bus Service) dated March 5, 2019.

WHEREAS, the Board has created a Pre Qualification Committee for the Accreditation of Premium Point to Point Bus Service;

WHEREAS, on 28 March 2019, the Pre Qualification Committee opened the sealed envelopes/boxes submitted by the applicants for additional PREMIUM POINT-TO-POINT SERVICES IN **PACKAGE 3** for the routes: **(a) Calamba, Laguna - Makati; (b) Calamba, Laguna - BGC/Fort Bonifacio, Taguig City (with special stop in Cabuyao, Laguna); (c) Calamba, Laguna - Lawton (with special stop in Cabuyao, Laguna)** with the total units of forty six (46), the following prospective applicants for Premium Point to Point Service submitted their respective Qualification Documents:

- 1) UBE EXPRESS INC.
- 2) HM TRANSPORT INC.
- 3) SAINT ROSE TRANSIT INC.

WHEREAS, Applicant **UBE EXPRESS INC.** was given by the Committee a "FAILED" rating for failing to comply with the Technical and Financial Qualification requirement as the Contract of Lease for garage is unsigned and the financial document submitted for Credit Line as fund source will show that Php 85,000,000.00 is not sufficient to acquire the compliant units;

WHEREAS, Applicant **SAINT ROSE TRANSIT INC** was given by the Committee a rating of "QUALIFIED" as submitted complete Qualification Documents and was given a rating of "PASSED" for each criterion

WHEREAS, Applicant **HM TRANSPORT INC.** was given by the Committee a "FAILED" rating for failure to submit original or certified true copy of the Or/Cr's and Passenger Accident Insurance documents and as the documents will show that the Applicant failed to submit the Contract of Lease between HM Transport Inc and Pascual Liner Inc for interim Service;

NOW THEREFORE, the Pre Qualification Committee resolves to recommend to the Board to **AWARD** in favor of **SAINT ROSE TRANSIT INC.**, to process further its Application for **PACKAGE 3** for the routes: **a) Calamba, Laguna - Makati; (b) Calamba, Laguna - BGC/Fort Bonifacio, Taguig City (with special stop in Cabuyao, Laguna); (c) Calamba, Laguna - Lawton (with special stop in Cabuyao, Laguna)** of the PREMIUM POINT TO POINT SERVICE under Memorandum Circular No. 2019-010;
