

RESOLUTION NO. 097 Series of 2019
**(Re: PRE QUALIFICATION OF PROPOSED ADDITIONAL
PREMIUM POINT TO POINT SERVICE UNDER MC 2019-010)**

WHEREAS, the Land Transportation Franchising and Regulatory Board (LTFRB) has created a Qualification Committee for the selection of applicants for Premium Point to Point Bus Service;

WHEREAS, on the scheduled date provided under Memorandum Circular No. 2019 -010, Re: IMPLEMENTING GUIDELINES ON THE OPENING OF PROPOSED ADDITIONAL PREMIUM POINT-TO-POINT SERVICES, or on March 22, 2019 between 9:00 AM and 2:00 PM, the following applicants for Premium Point to Point Service Packages 6, 7, 8, and 9 submitted their respective Qualification Documents before the Office of the Executive Director:

1. UBE EXPRESS, INC. (Packages 6 and 9); and
2. PABAMA CORP. (Packages 6, 7 and 8)

2. ENDORSE/FORWARD the Qualification Documents of UBE EXPRESS, INC. for Package 9, at the Office of the Regional Director of LTRFB Regional Office VI in Iloilo City;
3. Direct the Administrative Division of this Board to make the necessary endorsement and transmittal of records.
