

RESOLUTION NO. 098 Series of 2019
(Re: PRE QUALIFICATION OF
PREMIUM POINT TO POINT SERVICE)

WHEREAS, the Land Transportation Franchising and Regulatory Board (LTFRB) issued a Memorandum Circular No. 2019-010 (Re: Implementing Guidelines on the Opening of Proposed Additional Premium Point to Point Bus Service) dated March 5, 2019.

WHEREAS, the Board has created a Pre Qualification Committee for the Accreditation of Premium Point to Point Bus Service;

WHEREAS, on 2 April 2019, the Pre Qualification Committee opened the sealed envelopes/boxes submitted by the applicants for additional PREMIUM POINT-TO-POINT SERVICES IN **PACKAGE 13** for the route : **(a) BATANGAS CITY-ALABANG; (b) BATANGAS CITY- LAWTON** with the total units of fifty nine (59), the following prospective applicants for Premium Point to Point Service submitted their respective Qualification Documents:

- 1) CERES TRANSPORT INC.; and
- 2) DLTB CO.

WHEREAS, Applicant **CERES TRANSPORT INC.** was given by the Committee a "FAILED" rating for failing to comply with the Technical Qualification requirement by not submitting the following documents: 1) Letter of Support from the terminal in Alabang Endpoint; 2) Letter of Support from the terminal in Batangas City; and 3) Delivery Schedule from the manufacturer. Further, upon investigation of the Qualification Committee (per Board directive), the documents submitted by Ceres Transport, Inc. during the date of submission were contained in sealed envelopes while the documents presented during the opening of documents were already contained in sealed boxes without the markings set forth by the Selection Committee (i.e, stamp received and numbering);

WHEREAS, Applicant **DLTB CO.** was given by the Committee a "FAILED" rating for failing to comply with the Technical Qualification requirement by not submitting the following documents: 1) Letter of Support from the terminal in Batangas City; and 2) Undertaking that the units shall be compliant with the specifications and standards under OFG and DTI-PNS;

NOW THEREFORE, the Pre Qualification Committee resolves to recommend to the Board to **RE-OPEN** to prospective applicants **PACKAGE 13 (a) BATANGAS CITY- ALABANG; (b) BATANGAS CITY LAWTON** of the PREMIUM POINT TO POINT SERVICE under MC 2019-010.
