SUBJECT: AMENDMENT TO MEMORANDUM CIRCULAR NO. 2019-011 RE: GUIDELINES, RULES AND PROCEDURES ON THE DISPOSAL OF IMPOUNDED AND ABANDONED VEHICLES

WHEREAS, on March 11, 2019, Memorandum Circular No. 2019-011 was issued providing the guidelines, rules and procedures to be followed in the disposal of impounded vehicles;

WHEREAS, in the above MC, the Board, inadvertently failed to consider that the Regional Franchising and Regulatory Offices (RFROs) nationwide have the same predicament as regards impounded vehicles;

WHEREAS, Item No. 1 thereof provides in passing that
"1. The Technical Division of the LTFRB shall prepare an inventory x x x "

To now read as

"1. The Technical Division and the concerned RFROs shall prepare an inventory x x x "

WHEREAS, Item No. 2 thereof provides in passing
"2. x x x The minimum price for each vehicle shall in no way less than the total unpaid fines, penalties, surcharges and storage fees imposed on and incurred by each particular vehicle."

Which must now read as

"2. x x x The price of each of the vehicle is to be determined by the adjuster duly accredited by the Board, taking into consideration the present condition of a particular vehicle, which price shall be applied to the unpaid fines, penalties surcharges including the necessary fees of the duly accredited adjuster."

All provisions inconsistent herewith are hereby superseded and amended accordingly.

This Memorandum Circular shall be effective immediately upon its publication in the Official Gazette or in a news paper of general circulation.
