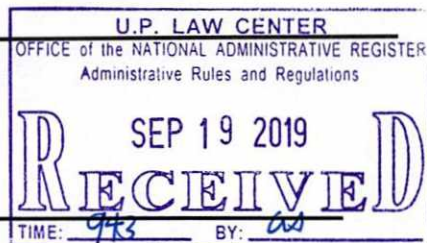

**SUBJECT:** **AMENDMENT TO MC NO. 2019-032**



**WHEREAS**, On July 23, 2019 issued Memorandum Circular No. 2019-032, Re: Opening of Application for New Certificate of Public Convenience (CPC) to Operate Premium Taxis with its Corresponding Features and Specifications Pursuant to Department Order No. 2019-007 (Amending D.O. 2015-011), Which Shall Be Known as “Taxi Modernization Program”;
